# **Privacy Policy and Terms of Service**

This Privacy Policy and Terms of Service ("Policy"), governs your use of or interactions with our services as described on our website.

By using our website or our services, you consent to and agree to comply with this Policy.

PLEASE READ THIS POLICY CAREFULLY BEFORE USING ANY OF OUR SERVICES.

## 1. Security of your Account.

- 1.1. Account Creation and Credentials. To use our services, you may be required to register an account and/or to register as a use, subject to acceptance by us in our sole discretion. To do so, you may be required to provide us with information, including but not limited to your name, email address, physical address, health formation and other information. You may also be required to provide us with information about your healthcare. You agree that the information you provide to us is accurate and that you will keep it up-to-date at all times. Uses may be asked to create a strong password and provide a device on which to receive a multi-factor authentication code (collectively, the "Credentials"). You agree to keep Credentials confidential and secure and will not give or make your Credentials available, directly or indirectly, to any unauthorized individual. You are solely responsible for maintaining the confidentiality of Credentials, and to the extent allowed by law, you accept responsibility of all activities on your account authenticated through Credentials, whether authorized or not. You acknowledge and agree that if you allow, whether through action or inaction, a person to gain access to Credentials, with or without permission, you are authorizing that person to use your account, and you will be responsible for all disclosures and other matters that result from such access, even if they are fraudulent or unauthorized. website services are provided AS IS and AS AVAILABLE and may be interrupted from time to time beyond our control, including from outages, Acts of God, or Malware or viruses.
- 1.2. Lost or Compromised Account or Credentials. You agree to immediately notify us if you believe that your account has been compromised or accessed without authorization, that someone has attempted or may attempt to make or request payments your account without authorization, or that Credentials have been lost or compromised.

1.3. **Reasonable Security Procedures.** You acknowledge and agree that the security procedures provided by us are a reasonable method of verifying your identity.

# 2. Usage Restrictions

- 2.1. **Acceptable Use Policy.** You promise that you will not use our website or services in connection with any activity prohibited by us or by law. We reserve the right, in our sole discretion, to update or change the acceptable use policy at any time.

You hereby authorize our access to your ePHI.

# 3. Rights You Grant.

- 3.1. **No Marketing.** We will not list or identify you as a client or patient without your express written consent. You may revoke this consent at any time.
- 3.2. **Contacting You.** As permitted by law, your use of or interaction with our website or services provides your consent to receive informational emails, promotional mailings, calls and text messages at the telephone number(s) provided to us by you. Standard rates and text charges may apply. you can opt out of receiving messages at any time by contacting us.
- 3.3. **Recording of Telephone Calls**. You understand and agree that we may monitor any telephone calls between us for purposes of quality control and for our protection. If you do not consent to the recording of telephone calls by us, do not engage with us by means of a telephone call, or let us know in writing and we will not do so.

- 3.4. **Account Termination**.
